MINUTES of Parish Council Meeting held on Tuesday 2nd December 2014 at the Village Hall, Stramshall.

12.14.1 Apologies: Messrs. R. Jones , T.Postlethwaite and J. Whittaker.

8.03 Several members of the public were present in respect of Item 8, Planning Application P/2014/01537 Pym and Wildsmith Ltd, Units 17, 17B, 17F, G & H Bramshall Industrial Estate Bramshall Staffordshire. The item was brought forward to allow the members of the public to discuss concerns. The predominant concerns raised were in respect of noise, increase in traffic and the proposed extension of working hours from 6am-10pm (current permission) to 24 hours per day, Monday to Sunday including Bank Holidays (proposed operational hours). Mr Pym, one of the applicants, also present at the meeting, explained that there would be no shot-blasting overnight and that the doors would remain closed thereby minimising noise. An increase in operational hours would increase local employment and secure the future of the business. He extended an offer to anybody wishing to look around the unit to contact him. All members of the public were given an opportunity to speak before leaving the meeting.
