# **Uttoxeter Rural Parish Council**

01.15.2. MINUTES: The minutes of the last meeting held on Tuesday, 2 December 2014, having been circulated, were signed by the chairman on the approval of the members.

#### 01.15.3. CLERK'S REPORT:

3.01 The Clerk had nothing to report due to it being her first meeting as the new Parish Clerk. RJ reported the location of the drainage issue on Quee Lane as being SK 07706 30478 at the sharp left bend west of B5013. Mr Durose is currently unable to undertake the work required. ## 01.15.4. CORRESPONDENCE:

4.01 The Clerk read out an email received from a non-resident requesting advertisement of Grave Care business. It was agreed that the advertisement would be better suited for Church Noticeboards. AS to forward details to respective churches.

#### 01.15.5 DRAFT SUSTAINABILITY APPRAISAL

5.01 CW gave a brief summation of the draft sustainability appraisal. The appraisal shouldn't overly affect Bramshall and Stramshall villages; it is designed to manage growth sustainably. Comments to be made on preservation of green space between the villages and the Uttoxeter town in order to maintain their individual identities. AS to action.

#### 11.14.6 TRAFFIC CALMING:

6.01 A local resident was present at the meeting and brought the Parish Council a review of the actions they have been taking concerning speeding traffic. JPE and DO gave overview of the issues to-date. The resident explained that they have been in contact with several organisations to resolve the problem. The resident requested support from Parish Council to ask for local interest from the community for Volunteer Speed Watch Campaign. DO nominated the resident to act on behalf of the Parish Council to co-ordinate the campaign for Bramshall and Stramshall. To advertise in Parish Newsletter in Bramshall and Stramshall. AS to action. AS to investigate prices of solar-powered speed signs. 6.02 Concern was raised about an overgrown hedge outside the carwash in Stramshall. DO to make enquiries into who

owns the land.

6.03 The resident brought to the Council's attention a spring the flows across the road around the area of Hollington Lane and the main road passing through Stramshall. It is believed that during the cold weather, the water from the spring has frozen on the road and a car driver has spun out of control and hit a wall in the village. There is no known person responsible for this wall, which is currently in a poor state of repair following suspected collision. AS to investigate legal implications of houses that have been left for a number of years. Current drain taking the spring water runoff is located in the wrong place and ineffective, located on the opposite side of the road from the overspill of the spring. AS to investigate whether spring is responsibility of the church. AS to write to Chris Mitchell requesting change in drain position and a gully to redirect the flow of water.

### 01.15.12. COUNCILLORS' REPORTS:

13.02 Concern from the local resident present at the meeting, that there were not enough litterbins available in Stramshall area, in particular, between Stramshall and Spath. AS to contact ESBC.
