The Councillors were informed that the previous Clerk of the Council, Malcolm Bagguley, had sadly passed away. A condolence card was signed by all Councillors and a donation of £25 will be made to a Cancer Charity.

Footpath URPC42b was reported by a resident. Clerk reported this to rightsofway@staffordshire.gov.uk on 27.04.2018. Cllr Ollerenshaw will take a photo, as requested by Rights of Way Team.

Dog Mess in Stramshall -Clerk to contact the Dog Warren and ask if they can issue the Council with some pink paint to spray any mess found.

Permanent 'Community Speed watch Area' Signs – Councillors discussed the request to purchase 4 signs for Bramshall. The cost is £19.95 for the signs and £150 each to install by AMEY (SCC). The Councillors RESOLVED to purchase and have install 2 signs now.

Clerk to contact Michelle Shaker (Speed Watch coordinator, Police) to place order.

Naming a Lane – update from clerk. ESBC advised that the lane in question is classed Lane From Netherland Green To Highwood, Netherland Green, Uttoxeter. But a name plate would not be possible for this length of name. The fee charge of £200 plus £30 per property affected by the proposal, a formal consultation where all the residents affected would have to agree to the change. The Parish Council RESOLVED not to move forward with this cost and the Clerk to advise the resident of the procedure/cost so they can apply as residents.

2018 National Rural Crime Network Survey received. Councillors received posters for the noticeboards and Cllr G Smith will complete the survey on behalf of the Parish Council.

### 18.05.0012 COUNCILLORS REPORTS (information only)

Councillors requested a follow up with regards to the Tree that is dangerous on Bennetts Lane. Clerk to contact SCC/ESBC again.

Clerk was requested to report carriageway erosion by 1-6 Leigh Lane, Bramshall.

Clerk was requested to report pot holes on Pigeonhay Lane, Bramshall.

Clerk was requested to contact Richard Rayson, SCC, to request they review the Speed issue on B5034, as previous update was not acceptable.

Stramshall Telephone Box Library opening – Cllr Oulsnam and Cllr Ollerenshaw will contact Mr and Mrs Smith to find a suitable date for an official opening event.

Cllr Oulsnam reported to the Council that the triangle land opposite Stramshall Village Hall, was gifted to the Village in 1919 and was to be known as The Park.

Clerk was requested to report the gully opposite Springfield House, Stramshall to be blocked, cars are avoiding the flooded area and using the wrong side of the road or the verge, which has a drop of 2ft below it. A discussion took place about the gullies in the parish and how the answer, "seasonal maintenance rota" was not acceptable from SCC when requesting the machine to visit the parish. Clerk to submit a Freedom of Information request to SCC for the route that the gully machine takes within the parish and the schedule for clearing the Parish gullies and last date of visit.
