A19.05.005 CHAIRMAN REPORT FOR 2018/2019 - Mrs Pattinson-Evans

URPC have had a successful and busy year with many projects being undertaken. We have had 10 full Council meetings and other site visits have taken place to oversee projects. There have been approx. 50 planning applications received for 2018/2019, some from boardering areas of our neighbourhood and some which have gone to appeal.

The following are just a few highlights from this year:

The Parish Council undertook a Parish Questionnaire which was distributed to all houses in the Parish. There was a good return with several issues being highlighted in the responses – primarily, volume of traffic, speeding traffic, traffic calming and pot holes. There is still a lot of work to do around the issues raised and the concerns of parishioners.

There is a successful Speed Watch team in Bramshall, who are doing a sterling job, but volunteers are needed for Stramshall, especially as through traffic is increasing. Work on the Bramshall Chicane should be started later this year as \$106 Funds have now

New Swings were installed at Stramshall Playing Fields following a successful grant application from Tesco Bags of Help for this project.

Stramshall turned their Telephone Box into a micro library and this has proved to be a successful move.

Bramshall were highly commended in the Best Kept Village competition and have entered again this year. A litter pick and village clean up took place in Bramshall to help prepare for this.

Two commemorative World War 1 Benches have been installed – one in each Village. They both look stunning in their respective settings. Thank you to Tesco and Cllr Colin Whittaker for funding for this project.

A comprehensive tender process was undertaken for the grass and hedge cutting in the Parish so that best value could be maintained. A 3-year contract was awarded.

The Woodland Trust provided saplings which have been placed around Stramshall Playing Field with the help of the Scouts.

A Gateway Sign was installed in Stramshall, thanks to the funding obtained by Aggregate Industries.

Once again Stramshall held a successful Christmas Tree lights switch on, with Bramshall to join them this year.

That just leaves me to thank our Clerk, Ginny Gibson, for all her hard work and support, Tom Ollerenshaw for this support as Vice Chair and all Councillors for their hard work this year. Thank you to Colin Whittaker for his continued advice, support and funds. One last thanks you to the retiring Councillors, Cathy Smith and Tom Postlethwaite for their work as Councillors and a warm welcome to our two new Councillors Andrew Dartnell and Matt Slater.
