

## **ROAD TRAFFIC REGULATION ACT 1984**

### **STAFFORDSHIRE COUNTY COUNCIL (B5027 STONE ROAD, BRAMSHALL AND B5027 BRAMSHALL ROAD, UTTOXETER) (40 AND 50 MPH SPEED LIMIT) ORDER 20\*\***

1. Staffordshire County Council propose to make a Traffic Order under the Road Traffic Regulation Act 1984, to impose the following speed limits:-

40 mph speed limit on B5027 Bramshall Road, Uttoxeter.

50 mph speed limit on B5027 Stone Road, Bramshall.

## **ROAD TRAFFIC REGULATION ACT, 1984**

### **STAFFORDSHIRE COUNTY COUNCIL (B5027 STONE ROAD, BRAMSHALL AND B5027 BRAMSHALL ROAD, UTTOXETER) (40 AND 50 MPH SPEED LIMIT) ORDER 20\*\***

The Staffordshire County Council ("the Council") in exercise of its powers under Sections 84(1) and (2) of the Road Traffic Regulation Act, 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. No person shall drive any motor vehicle at a speed exceeding 40 mph on the length of road specified in Schedule 1 to this Order.
2. No person shall drive any motor vehicle at a speed exceeding 50 mph on the length of road specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. This Order may be cited as the Staffordshire County Council (B5027 Stone Road, Bramshall and B5027 Bramshall Road, Uttoxeter) (40 and 50 mph Speed Limit) Order 20\*\* and shall come into operation on day of 20\*\*.

#### **SCHEDULE 1 (40 MPH)**

**B5027 Bramshall Road, Uttoxeter** – starting 130 metres north east of its junction with Stocks Lane to a point 70 metres south west of its junction with Ivinson Way, a total distance of 750 metres.

#### **SCHEDULE 2 (50 MPH)**

**B5027 Stone Road, Bramshall** – starting 150 metres west of its junction with Church Lane to a point 630 metres in a south westerly then north westerly direction.
