20.03.004 TO RECEIVE AN UPDATE ABOUT PROGRESS OF RESOLUTIONS FROM PREVIOUS MEETING

SEVERN TRENT COMMUNITY GRANT – WATER TROUGH -

A consultation letter was sent to all allotment holders, with SA Postcard on 08.02.2020.

After collating response, the Clerk applied to Severn Trent for £5,936 to install two further water troughs, a wild flower boarder on the verge at the entrance of the allotments and repairs to the boundary fence, under electricity pole. Clerk updated allotment holders via a notice on noticeboard. Councillors discussed the Bee Hive suggestion and RESOLVED to consult all

holders on the idea.

Resident reported damaged fence on field opposite Stramshall Playing Fields – Clerk contacted landowner, who will review.

Register of Interest Form sent to Cllr P Smith – this was returned to ESBC on 26.02.2020. DSK Engineering – instructed to install hinges on play area gate, stramshall playing fields.

Oak Tree – clerk informed resident that tree will be planted as soon as clerk health improves.

Toothill Lane Verge – update from Cllr Whittaker who carried out site visit - This winter has severely tested the roads, ditches and verges and all we do need is a prolonged spell of dry weather.

Clerk updated resident about the installation of Speed Indicator Signs installation – as a follow up to her email on September 2019.

Stramshall Playing Fields – Clerk used her delegated powers to instruct WH Durose to cut down a fallen tree on playing fields. 09.02.2020.

Allotment holder – Plot Number 12b – gave notice on his plot 20.02.2020. Hedge – Broomyclose Lane, Stramshall – some of this hedge, that the Parish Council maintains, has been replaced by fencing – new hedge length is 12m. Cllr Oulsnam will contact owner to find out if they will now maintain the hedge on the footpath side. 25.02.2020

Coroner - Mr Andrew A Haigh HM Senior Coroner for Staffordshire South was contacted and Clerk requested the Parish Council be registered as a "person of interest" for Mrs Cathy Smith inquest. This request was denied. 28.02.2020. Archives - emailed Mr Jones re archive minutes – 2003 -2009 and asked if he had any of them.

A50 – Project B – clerk wrote to Cllr Atkins, Kate Griffiths MP and Project Manager A50 to ask for an update and plans of the proposed site 26.02.2020. Bramshall Newsletter – update on the chicane was sent for publication 26.02.2020.

ACE – Stramshall Group - clerk emailed them to ask if they had a bank account yet and when they would like their grant – highlighted that funds were available to them regardless of what was on their Facebook page 26.02.2020.
