## STAFFORDSHIRE COUNTY COUNCIL (A518 STAFFORD ROAD AND A518 OLD KNOTTY WAY, UTTOXETER) (REVOCATION OF 40 MPH SPEED LIMIT) ORDER 20\*\*

The Staffordshire County Council ("the Council") in exercise of its powers under Sections 82(2) and 83(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The lengths of roads specified in the Schedule to this Order shall become restricted roads for the purposes of Section 81 of the Road Traffic Regulation Act, 1984.
- 2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- 3. The 40 MPH Order is revoked in so far as it relates to this Order.
- 4. This Order may be cited as the Staffordshire County Council (A518 Stafford Road and A518 Old Knotty Way, Uttoxeter) (Revocation of 40 MPH Speed Limit) Order 20\*\* and shall come into operation on day of 20\*\*.

#### **SCHEDULE**

**A518 Stafford Road, Uttoxeter –** starting from the roundabout with B5027 Stafford Road to a point approximately 110 metres south west of the junction with B5013 Abbots Bromley Road.

**A518 Old Knotty Way, Uttoxeter –** starting from the roundabout with A518 Stafford Road and extending for a distance of approximately 15 metres in an easterly direction.
