22.07.003 STRAMSHALL S106 – TRAFFIC CALMING DESIGN – UPDATE FROM STAFFORDSHIRE COUNTY COUNCIL.

Further to minute Reference 22.06.005, Staffordshire County Council replied to Council request for new design with estimated prices for the design.

"The Parish Council has been awarded S106 contribution of £16k for traffic calming in Stramshall. The following is an estimate cost for the new design submitted by the Parish Council. Changing the remaining 5 sets of cushions to road humps would typically cost £30-35k and the raised table at the Hollington Lane junction would be at least £45-50k due to the amount of work required to lift ironwork, kerbs, adjacent footways and adjust levels at the interfaces with driveways. There is also drainage to consider which would need specialist design input if the scheme is progressed to detailed design."

Councillors discussed the above costs and the considerable difference in funds available and funds needed for proposed design. RESOLVED to discuss further in September meeting.

22.07.004 BRAMSHALL CHRISTMAS TREE – Village Green – CONSIDER AND APPROVE Resident requested a second Christmas tree in Bramshall, by WW1 Bench. Councillors reviewed budget and RESOLVED to provide a tree and footings. Resident agreed to provide decorations for the tree. Clerk to obtain permission from ESBC Open Spaces Team and obtain a quote for footing from Ian Davies Fabrication, Bramshall.

P/2021/00969 - Land West of Ashbourne Road Spath Stramshall Uttoxeter ST14 5AD - Change of Use to a Gypsy / Traveller Site to provide 3 no. family pitches including 3 x Amenity blocks, formation of earth bund, level changes across the site, package treatment plant and alterations to existing driveway (Revised boundary, updated Flood Risk Assessment and new Ecological Assessment)

Uttoxeter Rural Parish Council welcomes the revised reports for the application. The Parish Council notes the information and the recommendation in the GeoSmart Flood Risk Assessment and the Camlad Ecology Itd Ecological assessment. The Parish Council are concerned that this is an aspirational application and does not demonstrate a local need. The Parish Council would like to provide further comments regarding the flood area. The site lies in open countryside as defined in SP 2 of the Local Plan. The development lies within the flood plain of the River Tean as per Environmental Agency documentation. With the addition of the earth bunds around the site when the river does flood (which is more frequent due to climate change) the flood water will have to be displaced across new ground probably the adjacent property and the road to Spath and Stramshall causing un-wanted flooding. The note from the applicants that the adjacent culvert will cater for the flood water is incorrect as when the river does flood so does the culvert which is connected directly to the river, the adjacent property is not currently affected by this as it is situated on higher ground with a concrete wall of the
