I cannot start this report without first mentioning the sad passing of former Councillor, David Oulsnam. Cllr Oulsnam was a very well-known and respected member of the community. He worked tirelessly for the betterment of the Parish.

As a relative newcomer to the Council, my period of knowing Cllr Oulsnam was quite short, but I soon learnt he was a very knowledgeable and helpful member of the Council who commanded respect from all Councillors.

As a mark of respect, the Parish Council are busy making a memorial area in the allotments (a place he loved), where people can go and reflect. His memory will live on.

It has been a year of change on the Parish Council. It was good to get back to meetings in person and in a new venue, Wilfred House.

After a turbulent period, we welcome several new councillors, Cllr Crosby, Cllr Sargeant, Cllr Dobson, Cllr Moss and Cllr Brookes. Stability has now returned to the Council and we look forward to working together to deliver the projects the community want.

In the last 12 months, the Council have been working hard on various projects, Speed signs have been installed in Bramshall and work has started on constructing a village gateway with more to follow.

We held an open meeting in Bramshall and without doubt, speeding and traffic is a big issue and we will continue to work with Staffordshire County Council and the local Speed Watch Group to manage the situation.

Similar traffic issues exist in Stramshall and we are pushing for the S106 funds to be spent on traffic calming, this was delayed due to Covid for 2 years.

The Wildflower border in Stramshall should soon be a welcome sight at the entrance to the Village.

Our work on the local footpaths continues, making a safe and accessible route to enjoy the beautiful countryside in our Parish.

The Football Goals have been installed this year on Stramshall Playing Fields along with a seesaw in the play area. A local family donated a bench so that residents can watch the football matches that are played. We continue to work to keep the playing fields a safe and enjoyable space. In the future it would be nice to have similar in Bramshall.

Work is also ongoing in negotiating with the Quarry in Spath to bring forward the green spaces and recreational facilities that have been promised.

Elsewhere, work on traffic warning signs have been installed at Loxley Lane Junction, this project was in conjunction with Kingstone Parish Council and Staffordshire County Council. Work is ongoing to redesign the junction to make it safer.

Thank you to all the Councillors for giving up their time and for the work in making the Council deliver their community wishes.

Finally, thank you to our Clerk, Mrs Gibson, for her hard work in sometimes difficult situations, in managing all aspects of the administration for the Parish Council.

The Parish Council would like to Thank Cllr Jones for his service to the Council during the last year.
